### 1. Assumption of Risk:

### 2. Accompanied Children:

### 5. Compliance with Rules:

I agree to comply with all rules and guidelines set forth by Cheery Cat during my visit. I understand that failure to follow these rules may result in being asked to leave the premises.

### 6. Medical Emergencies:

In the event of a medical emergency during my visit, I authorize Cheery Cat's staff to seek medical attention on my behalf and agree to bear all associated medical expenses.

### 7. Personal Belongings:

I understand that Cheery Cat is not responsible for any loss, theft, or damage to personal belongings during my visit.

### 8. Governing Laws

This Agreement will be governed by the laws in force in Canada and the Province of Alberta excluding the application of its conflicts of law rules. All matters in dispute under this Agreement shall be submitted to arbitration at the insistence of either party. The laws of the Province of Alberta shall govern the arbitration.
